## SECTION 4: First aid measures

### 4.1 Description of first aid measures

#### General information:

Move out of dangerous area. Move into fresh air and keep at rest. If medical advice is needed, have product container or label at hand.

#### Inhalation:

Provide fresh air, warmth and rest, preferably in comfortable upright sitting position. Place unconscious person on his/her side in the recovery position and ensure breathing can take place.

### 4.2 Most important symptoms and effects, both acute and delayed

#### Symptoms:

May cause skin and eye irritation. High vapour concentrations may cause drowsiness and irritation.

### 4.3 Indication of any immediate medical attention and special treatment needed

#### Treatment:

Treating the symptoms (decontamination, checking vital functions). No specific antidote known. To prevent pulmonary edema: corticosteroid-containing metered dose inhalation.

## 5.1 Extinguishing media

## 5.2 Special hazards arising from the substance or mixture:

Material reacts with water. Most foams will react with the material and release corrosive/toxic gases. Pressurised container may explode when exposed to heat or flame. In case of fire, toxic gases may be formed. Carbon monoxide. Carbon dioxide. Nitrogen oxides. Organic compounds. Hydrogen cyanide (hydrocyanic acid).

## 5.3 Advice for firefighters

### Special fire-fighting procedures:

Aerosol cans may explode in a fire. Water spray should be used to cool containers.
